
Annual Review for the St J's Group 2024





Rector's Report

In the last twelve months, since our last APCM in April 2023, we have witnessed the coronation of King Charles III (May 6 2023), India becoming the fourth country to land a spacecraft on the moon, the warmest global summer since record keeping began, flooding in Libya, the loss of the submersible Titan, Spain's women's team clinching the first Women's World Cup and renewed conflict in Gaza.

In the benefice we have celebrated 130 years of continuous worship at St John's Peasedown on Sunday June 25th 2023. We have witnessed the continuing growth of the All Age Worship service at Wellow, Little Ones and Fun Times in Peasedown as well as the successful launch of Bubble Church on Sunday December 3rd 2023 at St John's Peasedown. We welcomed Caroline McKinnell, a student from Sarum College, who was on placement with us for eight weeks and we also said farewell to Jo and Jerry Curd, to the Webb family and to Shaula Reilly our curate, as well as Ed Pope who sadly died in January 2024. We continue to delight in hearing the testimony from many about how God has moved and changed their lives in the last twelve months for the better.

Our teaching programme for 2023 focussed on 'One Body:many parts' - Paul reminded us: The body is a unit, though it is made up of many parts; and though all its parts are many, they form one body. So it is with Christ ... Now the body is not made up of one part but of many ... Now you are the body of Christ, and each one of you is a part of it. (1 Corinthians 12:12,14,27) It has been a continued pleasure, in the last twelve months, to journey alongside the four church families of the St J's Group. Without question God has gifted each and every one of us uniquely. We have different personalities, skills and experiences. We also have different capacities, vulnerabilities and circumstances. As every part of the benefice body has played their part in the last twelve months, it has been a delight to witness the whole benefice continuing to mature in Christ.

Deanery Synod and the Deanery MPG (leadership team) have continued to meet regularly. Matthew Street is still Area Dean having been appointed for a further six year term. The post of Lay Dean is currently vacant but with confirmation of Matthew's reappointment, a new Lay Dean can be appointed and vacancies on the DMPG filled. The MSN Deanery 5-year plan continues to be under discussion.

There have been no major changes around the MSN Deanery apart from the arrival of Nathanael Worsley as curate in the Waterside Benefice. As well as Shaula, other curates from the deanery will be moving on by the end of June apart from Philip Hopper who is staying at St John's Midsomer Norton as a self supporting minister.

The 2023 Annual Deanery Service took place on Sunday 30th July in St John's Midsomer Norton, lead by Ian Rousell and was an opportunity to hear from members of each benefice what God has been doing.

The 2024 Deanery Service will take place on Sunday 28th July.

A pulpit swap took place on 10th September with churches having the opportunity to experience something different as we seek to strengthen our bond as one church with many parts. This will not be repeated in 2024.

There is now a regular monthly newsletter sent to all Deanery Synod members and a link to this is in the StJ's Group E-news to share news around the deanery.

Twelve months have passed and sadly we are still awaiting permission to install kitchen/toilet facilities that St Julian's so desperately needs.

A card reader has been installed and is working well.

Unfortunately St Julian's suffered criminal damage to a large number of its windows quite recently. Also a bench in the North field was damaged beyond repair.

Installation of CCTV cameras are being looked into.

During heavy rain and wind there is still a problem with rain coming in through the roof. It is proving very difficult to resolve/identify exactly why this is happening.

The Christmas Bazaar held in November was a joyful occasion enjoyed by many in the Parish. Also the Sparkle Party, organised by the friends of St Julian's was a huge success.

All of the Christmas services were well attended and four Weddings took place in 2023.

The Bells continue to ring for special Services and they have a strong band of ringers who meet to practice fortnightly at St Julian's.

At present there are seven members on the PCC with two members of the Church family showing an interest in joining.

The All Age Worship team, going into its third year, continue to hold a service once a month which is enjoyed by everyone.

At St Julian's there is a strong team of volunteers from the local community and the regular congregation who work together in many roles to help keep our Church up and running for everyone.

Secretary report

Project to create toilet and small kitchenette facilities inside the Church.

It is disappointing to report that despite several years of trying to get this building project underway the PCC is struggling to obtain a Faculty from the DAC to permit the necessary building works. While the need to protect the Grade 1 listed status of St. Julian's Church is fully appreciated. it is also right to remember the function of the Church. There is an urgent need for the very basic sanitary and hospitality facilities we are striving to introduce inside the Church. We pray that the DAC will actively help us to make swift progress with this building project. At present there is a sense that more obstacles than stepping stones are being placed in the way of success in achieving this project.

General

At St. Julian's we are so fortunate to have the active support of kind people who do so much voluntarily to keep the Church going. The PCC is very grateful to the dedicated helpers who clean the Church, maintain the grounds, provide beautiful floral arrangements and carry out many other tasks.

Grateful thanks also go to our wonderful Church Wardens and bell ringers.

I know that our excellent Treasurer fully supports this expression of grateful thanks to Ruth Brown, Book Keeper, who quietly and diligently works so hard on our behalf.

The card reader introduced in the Church is proving a success with more donations being made using that payment method. The PCC is monitoring the situation.

Unfortunately there has been a recent spate of vandalism in Wellow. In the case of St. Julian's Church this necessitated repair to windows and a commemorative bench. It has also prompted a review of security and current investigation into an appropriate CCTV installation.

As a result of Shaula Reilly's departure we are without a Curate. This will no doubt add to Matthew Street's considerable time pressures so the PCC will be standing by to help him wherever possible.
